END OF TAX YEAR

We're fast approaching the end of the tax year on 5th April and now is usually a good time to get everything together, ready to drop off at Jon's office.

Q: What is the end of tax year?

A: The end of tax year is when your current tax year allowance finishes, and then restarts in the next tax year. Your tax code will refresh if you're employed, and you'll need to submit your tax return by this date if you're self-employed. If you have an ISA, you're given a tax-free allowance on your ISA amount each tax year, so when the tax year ends and a new one begins, this tax-free allowance will start again.

Q: What are the deadlines for the 2022/2023 tax year?

A: There are two key deadlines that you need to know about for tax returns, which are:

1. The deadline to register for Self Assessment is 5th of October in any given year. This is essentially how you tell HMRC that you're earning untaxed income and something that Jon can manage for you.
2. The Self Assessment deadline is 31st of January, the year after the tax year you're paying for. So, if you were paying your 2022/2023 tax return, this should be paid before the 31st of January 2024.
